Georgia's Own Passport Sweepstakes Rules

OFFICIAL RULES

NO PURCHASE OR ACCEPTANCE OF AN OFFER NECESSARY TO ENTER OR WIN.

The Georgia's Own Credit Union Georgia's Own Passport Sweepstakes (hereafter referred to as "The Sweepstakes") is sponsored by Georgia's Own Credit Union, 100 Peachtree Street, Suite 2800, Atlanta, GA 30303 ("Credit Union".) The Sweepstakes is governed by these Official Rules. By participating in the Sweepstakes, each entrant agrees to these Official Rules, including eligibility requirements. The Sweepstakes is subject to all federal, state, and municipal laws and is void where prohibited by law.

<u>Eligibility</u>

The Sweepstakes is open to legal residents of both the United States and the State of Georgia. Must be 18 years of age or older as of April 23, 2021 to enter. Officers, Directors, Supervisory Committee Members, Employees, Agents, Successors and Assignments of Georgia's Own Credit Union and their immediate family members (defined as spouse, mother, father, in-laws, grandmother, grandfather, brother, sister, children and grandchildren) are not eligible to win.

Entry

The Sweepstakes begins at 12:01 am on April 23, 2021 and ends at 11:59:59 p.m. May 17, 2021. (The Sweepstakes period). Anyone who posts a photo on Georgia's Own Facebook or Instagram site using #GeorgiasOwnPassport during the Sweepstakes period is automatically entered to win. Manual Entries: Entrants must provide their name, address, phone number, and email address on a three by five (3 X 5) index card and mail it to: Georgia's Own Passport Sweepstakes', Attention: Marketing, P.O. Box 105205, Atlanta, GA 30348. Only cards received by midnight on May 17, 2021 will be eligible. Only one mailed entry per person per sweepstakes period. Georgia's Own Credit Union is not responsible for cards lost or damaged in the mail.

<u>Prize</u>

One (1) individual will be selected from among all eligible entries received during the Sweepstakes period to win a prize package which includes: Four (4) tickets to see the Atlanta Braves play the Pittsburgh Pirates on May 22nd at Truist Park, Four (4) tickets to Six Flags Over Georgia, Four (4) suite tickets to see the Atlanta Hawks (date TBD), and Four (4) City Pass tickets. The total prize package is valued at one thousand five hundred dollars (\$1,500). The odds of winning depend on the number of qualified entries received. ALL EXPENSES, TAXES, AND COSTS ASSOCIATED WITH ACCEPTANCE OF THE PRIZE, AND THE REPORTING CONSEQUENCE THEREOF, ARE THE SOLE OBLIGATION OF THE WINNER. PRIZE IS AWARDED WITHOUT WARRANTY OF ANY KIND BY SPONSOR, EXPRESS OR IMPLIED, IN FACT OR IN LAW, RELATIVE TO THE USE OF ANY PRIZE INCLUDING, WITHOUT LIMITATION, QUALITY, MERCHANTABILITY, AND FITNESS FOR A PARTICULAR PURPOSE.

To claim the prize, the winner must sign and return a release and affidavit of eligibility and publicity (including agreement to appear in photos, videos and other promotional announcements) to the Credit Union at P.O. Box 105205, Atlanta, Georgia 30348, upon receiving the prize; or the prize, in the Credit Union's sole discretion, may be forfeited. The prize is neither transferable nor exchangeable and will be awarded only if entrant complies with these Official Rules. No other consideration will be paid.

<u>Drawing</u>

The Sweepstakes drawing will be held on or around May 18, 2021. Only entries received before the end of the Sweepstakes period will be eligible. The odds of winning depend on the number of eligible entries received.

The one (1) winner will be notified via direct message on the social media platform used for entry or contacted at the phone number or email address provided on the write-in entry received. If a selected winner fails to contact the Credit Union to claim the prize within three (3) days of the date specified on the notification, or if a selected winner cannot be located through reasonable, good-faith efforts by the Credit Union, an alternate winner may be selected from among the remaining eligible entries.

If by reason of a printing, computer, production, or other error, more than one winning entry is claimed, all persons making purportedly valid claims will be included in a random drawing to award the prize.

In the event this Sweepstakes is compromised or becomes technically corrupted in any way, the Credit Union reserves the right to cancel, terminate, or suspend the Sweepstakes and in such event, to select winner for the prize by random drawing from among all valid entries received, up to such time of cancellation, termination or suspension.

<u>Publicity</u>

By submitting an entry form, each entrant grants the Credit Union, and those acting under its authority, permission to use his/her name, likeness, and comments for advertising or publicity purposes without payment of additional compensation, unless prohibited by law. This includes appearing in photos, videos and other promotional vehicles.

Data Collection/Privacy

The Credit Union will collect personal data about participants when they enter the Sweepstakes. Personal data includes: name, address, email address, and phone number(s). The information collected is never sold, given or disclosed to third parties.

Indemnification and Limitation of Liability

By entering this Sweepstakes, each entrant agrees to indemnify, release, and hold harmless the Credit Union, its subsidiaries and affiliates, distributors, vendors, advertising and promotional agencies, suppliers and all their respective officers, directors, employees, representatives and agents from any liability, damages, losses or injury resulting in whole or in part, directly or indirectly, from entrant's participation in the Sweepstakes and the acceptance of the prize OR WHILE ENTRANT IS TRAVELING TO AND/OR FROM A LOCATION TO OBTAIN OR USE THE PRIZE. ALL SWEEPSTAKES WINNERS WILL BE REQUIRED TO SIGN A LIABILITY RELEASE PRIOR TO ACCEPTANCE OF ANY PRIZE.

FURTHER, NO RESPONSIBILITIES ARE ACCEPTED BY THE CREDIT UNION FOR ANY ADDITIONAL EXPENSES, OMISSIONS, DELAYS, RE-ROUTING, OR ACTS OF ANY GOVERNMENT OR AUTHORITY OR FOR FAILURE OF THE EVENT TO TAKE PLACE FOR ANY REASON.

Entrant agrees that any and all claims, judgments and awards shall be limited to actual out-ofpocket costs (but in no way including attorneys' fees, disbursements or court costs) and under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, punitive, incidental and consequential damages, and any other damages, other than for actual out-of-pocket costs.

Governing Law

All issues and questions concerning the construction, validity, interpreting and enforceability of these Official Rules, or the rights and obligations of entrants and the Credit Union in connection

with the Sweepstakes, shall be governed by, and construed in accordance with the laws of the State of Georgia.
